MOTION: Mr. Tembrina moved, Mr. Kessler seconded, to authorize Mr. DuBray to approach the FCRA about recovering dues that the Association has paid to the FCRA out of the budget, but have not collected from homeowners. The motion passed unanimously (3-0-0).
